Conditions of hire of Club facilities. Prices include GST.

1. Name and telephone number of contact must be left when original booking is made.

USE OF CLUBHOUSE FOR PRIVATE FUNCTION,

2. House Hire Fee: The Club charges a Fee of \$250.00 for the use of Clubhouse. Hire Fees include Club Staff wages up until 8pm. Any function operating past 8pm will incur an additional wages cost of \$40.00/hour for each staff member working the function. Staff requirements will be determined by the Club and any additional costs advised to the hirer prior to approving the Function. Additional staff costs will be paid as part of the amended Hire Fee.

3. Damages: The cost of repairs to furniture, fixtures and fittings and other property of the Golf Club will be charged to the hirer.

4. The Club Licence does not permit trading past midnight. The Club premises must be vacated by 12.30am. Guests are requested to depart quietly in consideration of adjoining residents.

5. Special requests are to be discussed with the Bar Manager and Catering Manager.

6. Entertainment required for a function will be arranged and paid for by the group organising the function. Organisers are reminded to be mindful of loud noise after 10.00 pm.

7. Advertising relevant to the function will be arranged and paid for by the group organising the function.

8. The group organising the function is responsible for bringing their own crowd.

9. Every group using the facility is responsible for the conduct and behaviour of their guests. Golf Club

Staff have the discretionary powers to control patron's conduct and behaviour. The Golf Club does not have child minding facilities so, while we do welcome children, parents must be responsible for their children so all patrons can enjoy their visit.

SPORTING FACILITIES.

10. Conditions and charges for hiring the Sporting Facilities (Golf Course, Bowls greens, Croquet lawn) are additional to the Hire of the Clubhouse above.

Golf:

Full Course Hire (i.e. Course Closed to all other players on the day)

Individual Green Fees ...9 Holes (\$20.00/player)18 Holes (\$30.00/player)

Motorised Cart Hire9 Holes (\$20.00).....18 Holes (\$35.00)

Hire sets of clubs and pull buggies will be complementary for your function.

Bowls:

Barefoot Bowls are arranged with the Bowlers. Fees are \$10/person. Bowlers will provide all equipment (bowls, mats and Jacks) and instruction for your function.

Croquet:

Croquet can be arranged through the Golf Club. Fees are \$5.00/person (max Hire cost is \$80.00).

Croquet Club will provide all equipment and instruction for your function. Soft sole shoes are to be

worn on the green.

11. SEMINARS: The hire fee for seminars will be \$220.

CATERING

12. The sale of refreshments at the Club and on any part of the sporting facilities is solely the domain of the Club. The Clubhouse and Course is part of the Club Liquor Licence and as such is NOT BYO.

13. Food catering facilities (kitchen and BBQ) are available for use subject to negotiation with the Club Catering Manager. Applicants will need to engage their own Commercial Caterer if required. The Caterer will be responsible for cleaning the kitchen and all Golf Club equipment used for your function. The Club reserves the right to refuse specific caterers use of our facilities. Use of the Club catering facilities are subject to negotiation with the Club Catering Manager.
